# Minutes of the COIN-OR Foundation, Inc. Strategic Leadership Board Conference Call

# 2 Minutes of the Meeting

The meeting was called to order by the President at 10:06 ET. In attendance: Bob Fourer, Kevin Furman, Lou Hafer, Robin Lougee-Heimer, Ted Ralphs, Matt Saltzman, Mike Trick. Absent: Randy Kiefer. A quorum was present.

## 2.1 Approval of past minutes

Kevin Furman moved to accept the minutes of the meeting of June 28, 2007; seconded by Ted Ralphs. The motion to accept the minutes was approved (unanimous).

#### 2.2 Election of Officers

Nominees for Officers of the COIN-OR Foundation, Inc., prior to the meeting, were Matt Saltzman, President; Ted Ralphs, Treasurer; and Bob Fourer, Secretary. All expressed willingness to serve, with the proviso that Lou Hafer would continue as acting Secretary until the end of March, 2008. Lou Hafer moved to close the nominations; seconded by Ted Ralphs. The motion was adopted (unanimous). Lou Hafer moved to adopt the slate of Officers; seconded by Matt Saltzman. The motion was adopted (unanimous).

#### 2.3 Authorisation for expenditures for routine legal services

Discussion: It was felt that the Board should consider authorising some level of expenditure to hire a lawyer for routine legal advice on intellectual property issues. There was discussion of current reserves and budget, and what we might reasonably expect in the way of support from major donors. A limit of \$5,000 was established as useful and acceptable to the members of the Board.

Lou Hafer moved that the Board authorise up to \$5,000 in expenses to hire a lawyer to advise us on routine legal matters related to intellectual property issues, and that the President be authorised to engage a lawyer for this purpose. Seconded by Kevin Furman. The motion was adopted (unanimous).

R. Lougee-Heimer will follow up on some referrals.

#### 2.4 Approval of Terms of Service for the website

The Terms of Service in Appendix A were presented for approval.

Discussion: It was pointed out that the Terms of Service stipulate that COIN-OR assumed ownership of material posted to the website, and that this implied that we now had an obligation to settle on an appropriate license for website content.

Moved by Kevin Furman that the Terms of Service be accepted as circulated; seconded by Ted Ralphs. The motion was adopted (unanimous).

M. Saltzman and T. Ralphs will make the appropriate modifications to the COIN-OR website. B. Hunsaker will be advised so that the Terms of Service can be incorporated into the ongoing website upgrade.

#### 2.5 Request to archive H. Mittelmann's benchmark data sets on COIN-OR

H. Mittelmann has an ongoing project to benchmark optimisation software. He uses a large collection of data sets, all of which are available from other repositories. A request was brought to the Board to archive the data sets used for mixed-integer programming benchmarks on the COIN-OR website.

Discussion: A number of issues were raised, including duplication of effort and licensing. Unilateral action might be seen as an attempt to usurp the role of other repositories maintaining benchmark data sets. There was a consensus that the appropriate course was to explore alternatives with current benchmark maintainers. B. Fourer, K. Furman, and R. Lougee-Heimer will act as an *ad hoc* committee to explore further.

#### 2.6 Other business

There was no new business.

A motion to adjourn was moved by Ted Ralphs; seconded by Kevin Furman. The motion was adopted (unanimous).

The meeting was adjourned at 10:59 ET.
